



## **GYMNASTICS (ARTISTIC) REGULATIONS**

**Last Update 01.04.2022**

### **1. Organization**

- a. The Gymnastics Committee of the 21st Maccabiah will be responsible for the Gymnastics competitions of the 21st Maccabiah.
- b. The Gymnastics competitions will be conducted under the 2021-2024 FIG code of points, FIG Statues and Technical Regulations
- c. Participation in the competition is open to any athlete who is in possession of a Participant Card issued by the Organizing Committee of the 21st Maccabiah and registered to the Gymnastics competitions.

### **2. Format of the Competition:**

Each country may enter one team of 4/5 male/boys for the males'/boys' competitions, one team of 4/5 females/girls for the females'/girls' competition. A Team is 4/5 gymnasts, performing 4 or 5 exercises in each apparatus, out of which the top 3 scores will count towards the total team score.

Countries that cannot participate with complete teams may participate with single gymnasts as follows:

- 1) Males up to 3 gymnasts
- 2) Females up to 3 gymnasts
- 3) Boys/Juniors (2004-2007) up to 3 gymnasts
- 4) Girls/Juniors (2007-2009) up to 3 gymnasts

A country cannot participate with a full team and individuals. The participation is either of a team or individuals.

### **3. Venues and Times**

- a. The Sport Department of the 21st Maccabiah will determine the venues and times of the Gymnastics competitions and teams will be notified accordingly.
- b. The competitions will be held in Gymnastics halls, according to the rules of the International Gymnastic Federation.

### **4. Program of the Competition**

- a. Competition for males: Composed of one optional exercise on the 6 apparatus in accordance with the Olympic selection. Floor exercise, Pommel Horse, Rings, Vault, Parallel Bars and Horizontal Bar.
- b. Competition for females: Composed of one optional exercise on the 4 apparatus in accordance with the Olympic selection. Vault, Uneven Bars, Beam and Floor exercise.
- c. Competition for junior boys: Composed of one optional exercise on the 6 apparatus in accordance with the Olympic selection. Floor exercise, Pommel House, Rings, Vault, Parallel Bars and Horizontal Bar.
- d. Competition for junior girls: Composed of one optional exercise on the 4 apparatus in accordance with the Olympic selection. Vault, Uneven Bars, Beam and Floor exercise.

### **5. System of Competition**

- a. Competition C1 (qualification) will decide team and individual all-around winners (Open and juniors).
- b. Competition C III will decide the individual winners on each apparatus.
- c. The OC shall have full consideration, pending on registration and competitors' level, with respect to the following:
  - o C III finals- whether or not to conduct and format of such final.
  - o Team Final- whether or not to conduct and format of such final.

### **6. Classification**

- a. Team Competition: The winning team will be decided by totaling the results of the 3 best scores on each apparatus in competition C1
- b. All-around individual competition: The all-around champion will be decided according to the results obtained by each gymnast on all apparatus together, in competition C1.
- c. Individual apparatus competition will be decided according to the results obtained by the gymnasts in competition C1, no more than 2 gymnasts per country will participate, up to 8 gymnasts (according to the total number of participants). If more than 8 gymnasts will have the same score, all of the gymnasts will participate in the individual apparatus.
- d. Scoring will be implemented according to the regulations of the International Gymnastics Federations, code 2021-2024.
- e. In case of a low number of participants and / or insufficient level, the organizing committee might decide to organize a common Open and Juniors Final (Competition III).

### **7. Judges**

- a. The Gymnastics Committee will appoint a Judges' Committee, which in turn will appoint the judges of the competition.
- b. Each country is invited to propose up to two (2) international judges with valid F.I.G brevet for the relevant cycle (2021-2024)/ National judges.
- c. The host country will complete judges according to the number of necessary judges (valid F.I.G brevet Judges and National level judges).



- d. It is hereby clarified that valid F.I.G brevet Judges shall be pointed as D panel judges, and national judges shall be appointed as Execution judges.

**8. General**

- a. These regulations are but one part of the complete 21st Maccabiah Regulations and must be read along with the instructions found in the Maccabiah Basic Regulations.
- b. In the event of a discrepancy between the regulations written here and those appearing in the Maccabiah Basic Regulations, the regulations written here will prevail, apply and be binding.
